On 3 May 2023 (after trading hours), the Company entered into the Placing Agreement with the Placing Agent pursuant to which the Company has conditionally agreed to place, through the Placing Agent on a best efforts basis, up to 40,000,000 Placing Shares at the Placing Price of HK\$0.375 per Placing Share to not less than six Placees who are professional, institutional or other investors that are third parties independent of the Company and its connected persons. The Placing Shares will be allotted and issued pursuant to the General Mandate.

Assuming there will be no change in the issued share capital of the Company between the date of this announcement and the completion of the Placing, the maximum number of 40,000,000 Placing Shares under the Placing represents (i) approximately 15.37% of the issued share capital of the Company as at the date of this announcement; and (ii) approximately 13.32% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares.

The Placing Price of HK\$0.375 per Placing Share represents (i) a discount of approximately 14.77% to the closing price of HK\$0.44 per Share as quoted on the Stock Exchange on the date of the Placing Agreement; and (ii) a discount of approximately 19.70% to the average closing price of HK\$0.467 per Share as quoted on the Stock Exchange for the last five consecutive trading days immediately preceding the date of the Placing Agreement.

Assuming that all the Placing Shares are fully placed, the estimated gross proceeds and net proceeds (after deducting the placing commission and other related expenses and professional fees) from the Placing will amount to approximately HK\$15.0 million and approximately HK\$14.7 million, respectively.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, the Placing Agent and its ultimate beneficial owner(s) are third parties independent of the Company and its connected persons.

Placing

The Placing Agent has conditionally agreed to procure, as agent of the Company, the placing to not less than six Placees in board lots who are individual, institutional or other professional investors that are third parties independent of the Company and its connected persons, for up to 40,000,000 Placing Shares at the Placing Price of HK\$0.375 per Placing Share on a best efforts basis. The Placing Agent will receive a placing commission of 2% of the aggregate amount equal to the Placing Price multiplied by the actual number of Placing Shares placed by the Placing Agent (i.e. the gross proceeds from the Placing).

The placing commission payable to the Placing Agent under the Placing Agreement is arrived at after arm's length negotiations between the Company and the Placing Agent with reference to the prevailing market commission rate for similar transactions. The Directors are of the view that the placing commission is fair and reasonable.

Number of Placing Shares

Assuming there will be no change in the issued share capital of the Company between the date of this announcement and the completion of the Placing, the maximum number of 40,000,000 Placing Shares under the Placing represents (i) approximately 15.37% of the issued share capital of the Company as at the date of this announcement; and (ii) approximately 13.32% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares. The maximum aggregate nominal value of the Placing Shares under the Placing will be HK\$4,000,000.

Placing Price

The Placing Price is HK\$0.375 per Placing Share which represents:

- a) a discount of approximately 14.77% to the closing price of HK\$0.44 per Share as quoted on the Stock Exchange on the date of the Placing Agreement; and
- b) a discount of approximately 19.70% to the average closing price of HK\$0.467 per Share as quoted on the Stock Exchange for the last five consecutive trading days immediately preceding the date of the Placing Agreement.

The Placing Price was determined on an arm's length basis between the Company and the Placing Agent and with reference to the recent market price of the Shares and the prevailing market conditions. The Directors consider that the Placing Price is fair and reasonable based on the current market conditions.

General Mandate

The Placing Shares will be allotted and issued under the General Mandate granted to the Board at the AGM held on 30 August 2022, pursuant to which the Board is authorised to allot, issue and deal with up to 50,094,528 Shares (as adjusted for the effect of share consolidation effective on 22 December 2022). As at the date of this announcement, save for the allotment and issue of 9,840,000 Shares (as adjusted for the effect of share consolidation effective on 22 December 2022) on 3 October 2022 under placing of new shares which have utilised the General Mandate, the Company has no other utilisation of the General Mandate. Accordingly, the remaining General Mandate is sufficient to cover the allotment and issue of maximum number of 40,000,000 Placing Shares under the Placing, and therefore the Placing is not subject to any additional Shareholders' approval.
